TRASH SERVICE REMINDERS

Waste Collection Schedule:

Mondays | Trash & Recycling Thursdays | Trash & Yard Waste

Reminder that trash should be placed in the trash toter provided by American Disposal where possible no earlier than 6:00pm the night before and containers should be collected back to your property by the evening of the pickup day. Yard Waste should be placed in bio-degradable paper bags or a personal trash container labeled "Yard Waste."

Tree limbs and bursh must be tied in bundles no longer than 4 feet in length and 6 inches in diameter, and should not exceed 50 lbs.

Bulk pickup which is usually provided for furniture and other large non-metallic household items, have been **SUSPENDED** because of COVID-19. If you have items which fall into this category for disposal, you can take them to the Fairfax County Dump (https://www. fairfaxcounty.gov/publicworks/recycling-trash/locationshours)

2020 Cluster Dues - Due June 30th

A reminder that letters for Cluster Dues went out in December to all homes. The dues assessment for 2020 is \$1320.00 per house, which are due by June 30th, afterwhich interest will acrue at a rate of 1.5% per month, charged on the first day of each month in which there is an unpaid balance until the account is paid in full.

If necessary, quartly statements will be mailed to all HCA members with an outstanding balance on the first of July and October, with additional reminders as needed.

All accounts with an overdue balance on December 31st will be referred to the HCA legal counsel for collection. After the account is referred and after due notice has been given, a lien will be filed against the title of the property. Should the account continue in arrears, further legal action may be taken. All legal expenses, including attorney fees, incured by the Hillcrest Cluster Association in seeking to enforce it's governing documents shall be added to the account balance, and shall be the basis for a lien and/or lawsuit to recover all sums owed.

Animal Waste Reminder

Here in Fairfax County, we love our dogs and clean water, too. We can have both if dog owners are responsible and clean up after their pets. Pet waste contains fecal coliform bacteria and can transmit diseases and parasites such as salmonellosis, cryptosporidiosis, and hookworm - just to name a few. These can make both humans and pets sick. Decaying pet waste can also contribute to fish kills in local streams and the Potomac River.

Always clean up after your pet. **IT'S THE LAW.** Failure to properly dispose of dog waste is a Class 4 misdemeanor and **subject to a \$250 fine** (County code, Section 41.1-2-6).

Several friendly reminder signs have been added around the cluster to help reinforce this for petowners passing through.



Recommended Maintenance: Gardening

Spring and early summer are perfect times to get outside and make progress on or update your home. While maintaining your garden is a year-round activity, this time is ideal for some key tasks.

You should take the opportunity to clean up leaves and garden debris, which can collect and trap moisture leading to mildew and water damage especially when adjacent to the walls of your home.

General gardening is a perfect spring/summer activity as new plants have the opportunity to thrive in the milder weather. Removing weeds will help the desireable plants stay healthy, and applying new topsoil and mulch can introduce much needed nutrients for plant growth and create protective layers to mitigate further weed growth. As a reminder for homeowners looking to mulch that red mulch, though available at local hardware and landscaping companies, is not permitted by Reston Association.

Lastly, some properties in the cluster have lawns which need to be mowed regularly by the homeowner. This maintenance is not performed on your personal property by our landscaping vendor, Blade Runners.

We look forward to seeing all of your hard work come into bloom through the year, and appreciate your personal contributions to beautify your homes and improve the look of the cluster.
